



PAWGUST 2026 INVITE A FRIEND COMPETITION

TERMS AND CONDITIONS

1. The competition ("Competition") is conducted by Guide Dogs Association of SA and NT Incorporated ABN 91 183 168 093 of 251 Morphett Street, Adelaide South Australia, 5000 phone (08) 8203 8302, ("Promoter"). As part of this, Guide Dogs Association of SA and NT Incorporated will represent Guide Dogs organisations across Australia and New Zealand.
2. Entry to the Competition constitutes acceptance of these terms and conditions. All entry instructions and prize information published by the Promoter form part of these terms and conditions.

ELIGIBILITY

3. The Competition is only open to individuals who have registered to participate in PAWGUST 2026
4. If the winner of the prize is under 18, the prize will be awarded to their parents/guardians.
5. The Competition commences Monday, 1st of June 2026 and closes at midnight AEST on Monday, 31st of August 2026 ("Entry Period").
6. To enter, entrants must invite a friend to register for PAWGUST 2024 by using the online invite a friend form located within the registration form, or the invite a friend form located on the fundraiser's dashboard. That friend must:
 - a. Not already be registered to participate in PAWGUST 2024
 - b. Complete a registration to participate in PAWGUST 2026 by visiting the PAWGUST website and completing the online registration form
 - c. Must complete their registration by Monday, 31st of August 2026.
7. There is no cost to enter the Competition; however, internet connection and usage rates may apply. Entrants should obtain details of such costs from their service providers. The Promoter is not and will not be liable for any such costs.
8. Entries must be received during the Entry Period. The Promoter takes no responsibility for late, lost, incomplete, incorrectly submitted, illegible or misdirected entries or for any delays or failures in any telecommunications service or equipment.
9. The Promoter may reject an Entry if it reasonably forms the opinion that the Entry has been entered using false information or via automated entry means or by use of a competition entry service.
10. The Promoter may, at its absolute discretion, declare an Entry made by an Entrant invalid if the Entrant tampers with the entry process, benefits from such tampering or submits an Entry that is illegible, incomplete or not in accordance with these terms and conditions.

THE PRIZES AND THE WINNERS

11. The individual who wins ("Winner") will be selected within 30 days of the competition ending (31st August).
12. The Winner will be notified via email within two days of the draw.



13. This prize will be awarded to a randomly selected eligible PAWGUST 2026 participant who successfully invited a friend to participate in 2026, and that friend successfully registered for PAWGUST 2026 via the PAWGUST website during the Entry Period.
14. Decisions of the Promoter are final and will be binding on each person who enters the Competition and no correspondence will be entered into.
15. The prize on offer is 1 x \$250 AUD Rebel gift card. One gift card will be awarded to the individual who invited a friend.
16. Any costs incurred by the Winners in participating in the Competition or claiming the Prizes that are not specified within the terms and conditions are to be borne by the Entrant.
17. The Prize notification will state that the Prize has been won and will include instructions as to how the Winners may claim the Prize and establish their entitlement to it. The Winners must be able to prove to the Promoter's reasonable satisfaction, that they satisfy the requirements of being an Entrant pursuant to these terms and conditions.
18. Should the prize not be claimed, the Promoter may conduct an unclaimed prize draw on Monday, 30th September 2026 to distribute any prize unclaimed by that date. The Winner of any unclaimed prize will be notified in writing via the email address provided in the registration form within two days of the draw depending upon the information they provided the Promoter when entering. The name of any prize winner will be published on the PAWGUST website on 2nd September 2024 for a period of no less than 28 days.

GENERAL

19. If for any reason the conduct or operation of the Competition is interfered with or disrupted in any way that is outside the control of the Promoter (including by vandalism, power failures, natural disasters, acts of God, civil unrest, strikes, computer bugs or viruses, tampering or technical failures), subject to any relevant lotteries or gaming authority regulation's, the Promoter reserves the right to cancel, terminate, modify or suspend or recommence the Competition.
20. The Promoter assumes no responsibility for:
 - a. any error, omission, interruption, or delay in the operation or transmission of any communication sent to (or by) the Promoter or any Entrant whether caused by problems with communication networks or lines, computer systems, software or internet service providers, congestion on any carrier network or otherwise,
 - b. any theft, destruction or unauthorized access to, or alteration of such communications;
 - c. any problem with, or technical malfunction of, any computer system or other equipment used for the conduct of the Competition;
 - d. any incorrect or incomplete information which may be communicated in the course of the administering this Competition (whether as a result of one of the foregoing causes or otherwise);
 - e. any delay in delivery, or failure of safe delivery of the Prize.
21. All of the Promoter's decisions are final and no correspondence will be entered into. If for any reason any element of the Prize becomes unavailable or not capable of being delivered to the Winners for any reason beyond the



Promoter's reasonable control, the Promoter will have no obligation to provide a similar prize to the Winners or otherwise compensate the Winners in any way.

22. All Entrants enter the Competition at their own risk and the Winner accept the Prize at his or her own risk. Except for any liability that cannot be excluded by law, the Promoter, its associated companies and agencies and any of their personnel (the "Relevant Parties") exclude all liability in respect of any loss (including any damage, claim, injury, cost or expense) which is suffered or incurred by any Entrant in connection with the Competition or Prize, including without limitation:
 - a. any indirect, economic or consequential loss;
 - b. any loss arising from the negligence of a Relevant Party;
 - c. any liability for personal injury or death.
23. Nothing in these Terms and Conditions exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees under the *Competition and Consumer Act 2010* (Cth) or similar consumer protection legislation in the States or Territories.
24. Prizes are not transferrable or redeemable for cash and are subject to availability.
