



PAWGUST 2026 Last Days Challenge – Terms & Conditions

1. Promoter

The competition ("Competition") is conducted by Guide Dogs Association of SA and NT Incorporated ABN 91 183 168 093 of 251 Morphett Street, Adelaide South Australia, 5000 phone (08) 8203 8302, ("Promoter"). As part of this, Guide Dogs Association of SA and NT Incorporated will represent Guide Dogs organisations across Australia.

2. Promotion Period

The Competition opens at **12:01am AEST on Thursday, 28 August 2026** and closes at **11:59pm AEST on Monday, 31 August 2026** (Promotion Period).

3. Eligibility

The Competition is open to individuals who:

- a) Are not employees of the Promoter or any of its related corporations or any of their agencies associated with the Competition; and
- b) for the Donor Prize Draw, successfully make a donation to a PAWGUST fundraising page via www.pawgust.com.au during the Entry Period; or
- c) for the Fundraiser Prize Draw, are a registered participant for PAWGUST and receive a donation on their PAWGUST online fundraising page during the promotion period.
- d) Entrants must provide their full name, mobile number and email address through the PAWGUST platform.
- e) Are 18 years old or over.
