1. Promoter

As part of this, Guide Dogs Association of SA and NT Incorporated will represent Guide Dogs organisations across Australia and New Zealand.

2. Promotion Period

The Competition opens at **12:01am AEST on Thursday, 26 August 2026** and closes at **11:59pm AEST on Thursday, 26 August 2026** (Promotion Period).

3. Eligibility

The Competition is open to individuals who:

- a) Are not employees of the Promoter or any of its related corporations or any of their agencies associated with the Competition; and
- b) are a registered participant for PAWGUST and receive a donation on their PAWGUST online fundraising page during the promotion period (this includes self-donations).
- c) Entrants must provide their full name, mobile number and email address through the PAWGUST platform.
- d) Are 18 years old or over.

4. How to Enter

- a) **Participant Prize Draw:** Registered PAWGUST participants will automatically receive one entry when they receive at least one donation through their PAWGUST fundraising page during the Promotion Period.
